

**OHIO TRAVEL CUP LINDSAY’S LAW/SUDDEN CARDIAC ARREST IN YOUTH ATHLETES WAIVER**

Lindsay’s Law, Ohio Revised Code 3313.5310, 3707.58 and 3707.59 went into effect in 2017. In accordance with this law, the Ohio Department of Health, the Ohio Department of Education, the Ohio High School Athletic Association, the Ohio Chapter of the American College of Cardiology and other stakeholders jointly developed guidelines and other relevant materials to inform and educate students and youth athletes participating in or desiring to participate in an athletic activity, their parents, and their coaches about the nature and warning signs of sudden cardiac arrest.

**REQUIREMENTS OF LINDSAY’S LAW/SUDDEN CARDIAC ARREST IN YOUTH ATHLETES**

Lindsay’s Law requires that each parent/guardian and athlete participating in youth sports must view the required SCA video; must receive a copy of the required SCA Informational Handout for Parents/Guardians and must sign the required Signature Form for Parent and Athlete. Lindsay’s Law also requires that each coach of a team participating in youth sports must view the required SCA video and must receive a copy of the required SCA Informational Handout for Coaches. **OHIO TRAVEL CUP REQUIREMENTS**

The Ohio Travel Cup requires compliance with Lindsay’s Law. To monitor compliance, we require that each team participating in the Ohio Travel Cup sign this waiver attesting to the following:

1. That all parents/guardians of youth athletes participating in the Ohio Travel Cup AND all youth athletes participating in the Ohio Travel Cup have watched the required video; have read the required informational handout; and that a parent/guardian and youth athlete have signed the required signature form.
2. That all coaches who will be on the sidelines at any Ohio Travel Cup game have watched the required video and that all coaches have read the required informational handout.
